83/20	<p>Matters Arising from the Monthly Minutes of the Meeting held on the 11th March 2020:-</p> <p>Page 1 Min.55/20 Glass in Wall Dangers reported during Public Forum:- Clerk reported on the response received from Matthew Taylor MP as follows – The glass is there to stop the wall being used to access his property by vandals. It is a last resort; he did put up a wire on top of the wall but it was pulled down. He could think of no other solution. The glass is only on top of that section, well above a height that anyone could hurt themselves unless trying to climb over the wall. To be clear, the vandals were endangering themselves, and more importantly his children, especially his 8 year old. To deter this he tried using just cut branches to block access, then the wire icon top of the wall - which were themselves vandalised. Unless the Parish Council can propose a better way to protect his 8 year old who was clearly endangered by these actions (which have ceased sine the glass was put there) he is not sure what to suggest. The glass is not oligarchs and as he says is on top of the wall only - not somewhere anyone should be. To be honest given similar incidents in the park, including vandals planting broken glass he understood similar to his experience around the children’s play areas, he was surprised to get a letter, as he thinks the Parish Council is well aware of the problem. Email from Development Management Highways Officer:- Following site visit on the 28th January 2020, he acknowledged emerging visibility from the southern entrance – which currently serves the property – is constrained. Given the proposed development, its trip generation is expected to be outside of network peak hours and unlikely to result in a material increase in vehicle movements. As such, it is not considered an objection on highway safety grounds could be sustained at appeal. In addition, he believes any further intensification of use – compared to that currently proposed – would require planning permission. Measures (signage within site exit) preventing right turning manoeuvres when egressing from the property would assist emerging drivers to position at a point where visibility would be acceptable, and he trusts this could be conditioned so as to be implemented before the proposal is brought into use. Update on PA18/09982 – Land at Edgcumbe Road, Roche:- Clerk reported the Planning Agent had been in contact to arrange a skype meeting with them and it had been agreed to go back at this requesting information as to what they wished to discuss and then make a decision if we needed to hold a skype meeting with them at the current time. Response received advising if anything is raised in respect of the housing scheme at Edgcumbe Road and or the A30 Link Road they would like to be kept abreast. They continued by saying that in light of the current circumstances which we find ourselves in and not being able to meet face to face they felt that at the present time it may prove too challenging to discuss remotely detailed matters concerning viability, design and the proposed planning obligations in an effective manner. As such, they shall therefore look to proceed on the basis of the agreed policy compliant package of planning obligations which cover affordable housing, education and public open space along with the off-site highways works. Suitable mechanisms are available to them to vary these obligations accordingly to local circumstance/need at a later date, if necessary and or required. They remain committed to a collaborative outcome on this project as has been our approach throughout this process. Councillor B. Higman advised there had also been an email received from Cornwall Councillor J. Wood in respect of planning during the coronavirus pandemic to keep in mind. Councillor M. Edyvean felt it is too big of a decision to go through without the road being put in place and suggest we should not like to see it “rubber stamped” before the road is in place, we would not wish to see it signed off or delegated before coming to a Parish Council Meeting as it is far too big and controversial. It was resolved to send comments to Cornwall Council, copying in Cornwall Councillor J. Wood and all Councillors (Proposed: Councillor B. Higman; Seconded: Councillor M. Edyvean) **Action:** Clerk. Councillor G. Rowe queried the link road from Harmony Road to Edgcumbe Road with the enforceable contract for this to happen, nothing has been seen to date regarding this. He is concerned the new road may be put on the “back burner” at the present time, especially if the 150 housing scheme starts.

85/20	<p>Land at Glebe Quarry Update:- Clerk reported this had been included in the recent newsletter report and no responses received to date. Cornwall Councillor J. Wood had been in touch with Cornwall Council and email circulated as follows:- Previous proposals were potentially not communicated clearly enough and whilst Cornwall Council came to the Parish Council with a “blank piece of paper”, the provision of a drawing may have confused and suggested the Council were coming with preconceived ideas. The A30 link was a big consideration and was potentially clouding judgement around a small affordable housing development (this may now be less of a consideration with the road due to start delivering later this year). We discussed the opportunity that with the Council delivering the scheme there was a greater scope to work with the Parish to deliver a scheme they were supportive of, rather than the risk of a private developer acquiring the site and delivering a scheme that did not maximise community benefit. I gave the example of Veryan where we are now delivering a small scheme with the full support of the Parish Council. A number of older residents were identified in the local area who are occupying larger homes and there could be scope to look at providing bungalows on this site to “right size” existing tenants and free up family sized housing for local households in need. In-terms of next steps, you advised you would discuss with the Parish the principle of coming back to them to discuss this opportunity and that subject to that being positive, we could come to the next Parish Council and discuss the options for the site? He would be happy to come and meet the Parish Council when and if would be appropriate. It was resolved to Cornwall Council advising we are in conversation with Cornwall Councillor J. The papers will now go to the Land Registry to undergo the usual registration formalities and can take anywhere from a few weeks to a few months and the updated register entries would be forwarded on once received.</p>																																																																															

	<p>Discussion on Cemetery Closure during Covid-19 Pandemic:- Clerk reported we now had to make a decision on the Cemetery and whether we close or keep open, although Government has stated it should be closed from the 26th March 2020 as per regulations circulated to Members. After speaking with local authorities, it was noted that Cornwall Council have not currently closed their Cemeteries, although a lot of local ones have now closed. CALC had suggested that if this is possibly classed as one of the only greenspaces locally for people to use and could be proved, it could possibly be kept open under these circumstances.</p> <p>Councillor. B. Higman expressed his concerns regarding risk assessments and not being able to wash hands, sanitize, etc.</p> <p>Councillor M. Edyvean advised that we ought to turn water off at the mains and remove all plastic water containers and let parishioners know and to advise that people can access through small side gate without touching gates. This could also be included with a caveat on a sign to say if Cornwall Council close cemeteries we will then follow their guidelines.</p> <p>It was resolved to compile new poster and advertise on Website and Facebook advising that the Parish Council respectfully ask people visiting the Cemetery to respect government guidelines and keep within social distancing and not to touch any taps, etc., advising the water mains will be turned off and plastic containers removed, access only through small side gate and no-one to touch any metal or walls on the way through or when in the Cemetery itself and to further add that if Cornwall Council close their Cemeteries we will then follow their guidelines and close the Roche Cemetery.</p> <p>It was resolved to keep it open with above provisos in place (Proposed: Councillor M.
